Pool finishes will determine bracket placement, Gold Division (1st in Pool), Silver Division (2nd in Pool), and Bronze Division (3rd in Pool). **If all three teams finish pool play with the same match record, ties will be broken on game record, and if needed point differential.**

Warm-ups – First two rounds of warm-ups will be 6-7-7, with subsequent rounds being 1-2-2. Each school needs to provide their own warm-up balls.

Scorekeepers will be provided by the host school. **Team not playing will need to provide 2 line judges.**
