PLAYOFFS: Will start approximately 20-30 minutes after final pool match is competed to allow the officials time to rest and eat prior to beginning. Teams will be placed into brackets based on pool play finishes (Pool A will play Pool D and Pool B will play Pool C.) Format will be Best of 3 sets; first two sets to 25 and third set to 15 (no caps)

PLAYOFF ROUND 3 Semi-Finals of Both Brackets (Championship Bracket on cts. 2 & 3; Consolation Bracket on cts. 1 & 4)
PLAYOFF ROUND 4 Finals of Both Brackets (Championship Game on ct. 3; Consolation Game on ct. 2)
